# Inside Edge Membership Form

## RELEASE OF LIABILITY, WAIVER OF CLAIMS, AND INDEMNITY AGREEMENT

By signing this document you will waive certain legal rights, including the right to sue.

**Please read carefully and sign on other side of this form!**

I hereby certify that I am nineteen years of age or older and I agree to abide by the guidelines, policies, procedures, and bylaws of the Inside Edge Club 1981 (hereinafter referred to as "The Club").

In consideration of The Club accepting my application for membership and permitting my attendance at The Club events and activities, I hereby agree as follows:

1. **TO WAIVE ANY AND ALL CLAIMS** that I have or may in the future have against The Club, and its directors, employees, agents, and representatives, (all of whom are hereinafter collectively referred to as "The Releasees") and to Release the Releasees from any and all liability from loss, damage, injury or expense that I may suffer, or that my next of kin may suffer as a result of my attendance at The Club events and activities due to any cause whatsoever, INCLUDING NEGLIGENCE, BREACH OF CONTRACT, OR BREACH OF ANY STATUTORY OR OTHER DUTY OF CARE, INCLUDING ANY DUTY OF CARE OWED UNDER OCCUPIERS LIABILITY ACT, R.S.B.C. 1979, c.303, ON THE PART OF THE RELEASEES.
2. **TO HOLD HARMLESS AND INDEMNIFY THE RELEASEES** from any and all liability for any damage to property of, or personal injury to, any third party, resulting from my attendance at The Club events and activities.
3. This Agreement shall be effective and binding upon my heirs, next of kin, executors, administrators, assignees, and representatives, in the event of my death or incapacity.
4. This Agreement shall be governed by and interpreted in accordance with the laws of the Province of British Columbia; and
5. Any litigation involving the parties to this agreement shall be brought within the Province of British Columbia. In entering into this Agreement I am not relying upon any oral or written representations or statements made by the Releasees other than what is set forth in this Agreement.

### MEMBERSHIP POLICY:

- Members must be 19 years of age or older and agree to abide by the by-laws and rules of the Constitution derived by The Inside Edge Club 1981 as defined by the Societies Act of British Columbia.
- There will be no refunds on membership dues once payment has been submitted to the Club.
- Members must be in good standing to be entitled to the benefits and privileges of The Inside Edge Club 1981.
